CONDITIONS

1. I authorize Elite Home and Pet Care to perform care and services as outlined above. I also authorize by my signature below, emergency veterinary care, releasing you from all liabilities related to transportation, treatment and expenses. I agree to reimburse you for all expenses incurred plus any additional fees for attending to this.
2. I agree to reimburse you for all fees incurred for extra food and/or supplies that must be purchased.
3. In the event of inclement weather or natural disaster, you are entrusted to use your best judgment in caring for my pet(s) and home. I will hold you harmless for consequences relating to such decisions.
4. I will be responsible for any injury (i.e. pet bites, etc.) requiring medical attention to you due to my pet(s) or condition of my premises.

Cat Clause – I understand that if my cat(s) stay outside, if I request that your service let my cat(s) outside, Elite Home and Pet Care is not liable or responsible for my cat's safety, and I assume the risk that my cat(s) may become lost or injured and require medical attention.

Dog Clause – I understand that Elite Home and Pet Care may encounter aggressive or unleashed dogs while caring for my dog(s) outside my home or yard and may not be able to prevent or stop every dog fight. I hold Elite Home and Pet Care harmless from any injury to my dog(s) resulting from a dog fight. I understand that if I leave my dog(s) in my yard, gated area, or otherwise, I agree to assume risk that my dog(s) may escape. Elite Home and Pet Care will make every reasonable effort to locate them and provide additional precautions that they deem necessary or reasonable to prevent a similar recurrence and I agree to reimburse them for time and expenses.

5. Elite Home and Pet Care agrees to provide the services stated on the client's information sheet, in a reliable, caring and trustworthy manner. In consideration of these services, as an express condition thereof, the client expressly waives and relinquishes any and all claims against said pet sitter and company.
6. I further authorize this contract to be valid approval for future service, permitting Elite Home and Pet Care to accept my telephone reservations for service. I will not assume a reservation until I have had verbal confirmation from Elite Home and Pet Care.
7. I am aware that all caregivers are bonded and insured through Elite Home and Pet Care and trained to perform all duties detailed on each client information sheet. In the event of an emergency by your normal caregiver, a substitute will be provided to perform services.
